Michael Siegel – We won't actively be looking. Would be caught at time of sale or inspection.

Discussion on way for home owner to keep in law suite and not be able to rent. Family could use but not rentable.

Curtis Dietrich – Recommendation on short term rentals.

Michael Siegel – Written as special exception. Could put in overlay districts as conditional use and that will end it. Should we define short term rentals or just prohibit use?

Was agreed to put as prohibited use at this time.

Some grammatical errors were found. Michael Siegel will change them.

Richard Dorney – Asked a few questions and was given clarification.

The floor was opened for public comment, hearing none, moved on with the agenda.

Susan McGorry made a motion to recommend to the Board of Supervisors to review the Zoning Ordinance changes, including approved changed. Thomas Zubey second the motion. Roll call: All yes. Motion carried.
